FFPSA Overview

- Part of Bipartisan Budget Act of 2018 (P.L. 115-123), signed February 9, 2018, comprised of eight Parts. Most significant include:
 - Part I New preventive service options
 - Part IV Requirements for non-foster family home placement settings
- Other parts amend existing provisions within Title IV-B and IV-E of the Social Security Act and reauthorizes existing programs through 2021
- Effective dates Range beginning retroactive to February 9, 2018 and extending to October 1, 2027
 - Part I 10/1/2019 yet depends on Part IV implementation date
 - Part IV 10/1/2019 through 10/1/2021

FFPSA Provisions:

Part I:

- Optional Prevention Services
- 50%FFP for Kinship Navigator Programs (EBP& trauma-informed)
- Licensed Family-Based Substance Use Treatment Facilities

Part II:

- Extension of family reunification services from 12 to 15 months
- Regional Partnership Grants
- National Electronic Interstate Compact Enterprise (NEICE)

Part III:

- Model licensing standards for relative foster family homes
- Additional reporting requirements to prevent Child Abuse and Neglect Fatalities

Part IV:

- Limitations & New Requirements on Congregate Care
- Criminal Background and Child Abuse Registry Check
- Protocols to Address Inappropriate Diagnoses

Part V

 John H. Chafee Foster Care Program for Successful Transition to Adulthood

Part VI:

• *IV-B & IV-E Reauthorizations through 2021*

Part IV/Section 50741 & 50742: Placement Settings & Additional Requirements

- Limitations on IV-E Foster Care Maintenance Payments:
 - Payments are limited to two weeks, unless specified setting as follows:
 - Specialized setting providing prenatal, post-partum, or parenting supports for youth
 - Supervised Independent Living Programs for youth 18+
 - High-quality residential care and supportive services to youth who are or who are at-risk of becoming, sex trafficking victims (CSEC)
 - Licensed Residential Family based treatment Facility for Substance Abuse (optional within Part I)
 - Qualified Residential Treatment Program (QRTP)

Part IV. QRTP Requirements

Facility Requirements:

- Serve children w/ serious emotional or behavioral disorders or disturbances
- Operate trauma-informed treatment model & organizational structure
- Registered or licensed nursing staff and other licensed clinical staff that:
 - Provide care within the scope of their practice as determined by State law;
 - Are on-site, according to the treatment model
 - Are available 24/7

Part IV. QRTP Requirements

- Facilitates outreach and participation of family members in child's treatment plan
- Provides discharge planning and family-based aftercare supports for at least 6 months post-discharge
- Accredited by CARF, JCAHO, CoA, other approved accrediting organization

Part IV. QRTP Requirements

- Assessment & Documentation
 - 30 day assessment by a Qualified Individual to determine the appropriate level of care
 - Qualified individual is a trained professional or licensed clinician not an employee of the state and who is not connected to/affiliated with the placement setting
 - Family and Permanency Team
 - Within 60 days of the start of each placement, the court shall determine appropriateness of placement
