SPEAKER BIOGRAPHIES

VERONICA ALLEN, MPA

CHARTIER SANFORD

Growing up in Sacramento, CA, Chartier experienced significant challenges as a youth, living away from his family in residential care after being removed from his mother and siblings. This eventually resulted in him becoming involved in both the Child Welfare and Juvenile Justice systems and he struggled with stability. Chartier was connected to team of support and championed for himself to successfully reunify with his family and graduate high school. Chartier is currently enrolled as a student at a local college and aspires to continue to champion for other youth involved in the juvenile justice system through peer supportive services. He has participated in training panels for the Continuum of Care Reform CFT orientations with the UC Davis Resource Center for Family Focused Practice.

ANGIE SCHWARTZ

Angie Schwartz is the Policy Director at the Alliance for Children's Rights where she has been instrumental in passage of key reforms including the extension of foster care to 21, creation of a state-only funding system for kinship foster parents, and development of a screening process to improve access to disability benefits. Prior to joining the Alliance, Angie was an impact litigator at the Public Interest Law Project and was a Skadden Fellow for the National Center for Youth Law. Angie earned her B.A., Magna Cum Laude, from American University, and her J.D. with distinction from Stanford Law School.
