THE COMMUNITY

Sierra County (pop. 3,000) is located just north of Lake Tahoe in the Sierra Nevada Mountains. The County is bordered by Plumas and Lassen counties to the north, Nevada County to the south, Yuba County to the west and the State of Nevada to the east. Elevations range from 1,800 to 8,589 feet, and large portions of the County are included in the Tahoe National Forest and a part of the Toiyabe National Forest.

Sierra County is a unique, rural and rugged place with a history and people rooted in the resources and natural features of its land: the high Sierra and its wildlife, scenery, recreation, watershed, forests, and gold resources; the agricultural Sierra and Long Valleys; and wild and scenic rivers flowing throughout the county, including the Little Truckee, Feather, and Yuba Rivers.

The County's communities maintain a unique character born in the historic resource industries of the area. From the gold mining town of Alleghany, to the agricultural lumber mill town of Loyaltown, and more recently the outdoor recreational tourism industry in Downieville, Sierra City, and the Lakes basin, the residents and visitors enjoy a rural lifestyle of changing seasons, national forests and exceptional recreational opportunities.

Sierra County offers a safe, rural lifestyle with year-round recreational opportunities including cross-country skiing, snowmobiling, mountain-biking, hiking camping and fishing.

THE POSITION

Under administrative direction of the Superior Court Presiding Judge, plans, organizes and directs the activities of the County Probation Department; provides expert professional assistance to the Superior Court, the Board of Supervisors and County management staff regarding adult and juvenile probation matters; performs advanced adult and juvenile probation procedures; conducts the most complex investigations in Adult Criminal Court and Juvenile Justice Court; structures and administers the Probation budget and grants; works collaboratively with other county departments; serves on various County commissions and/or task forces; provides information and assistance to the public, and does other appropriate work as required.

THE IDEAL CANDIDATE

The ideal candidate is a strongly committed individual who has an outstanding record of achieving goals and maintaining positive collaborative working relationships within an organization. This individual will also be open to solicit good ideas from all levels of the organization and will have the ability to earn others' respect and to foster innovative solutions to County problems with sound administrative practices and strategic planning skills.



EDUCATION AND EXPERIENCE

Any combination of training and experience that would provide the required knowledge, skills, and abilities is qualifying. Equivalent to graduation from a four year college or university with major coursework in psychology, sociology, criminal justice, or related field AND five years of increasingly responsible probation program experience, including at least two years of significant managerial experience.

Possession of a valid California driver's license and a satisfactory driving record, possession of a valid PC 832 certificate, possession of, or the ability to obtain within one year of appointment date, an Advanced Managerial Core Certificate from the Board of Corrections are required.
