PROMISING STRATEGIES TO SERVE AND SUPPORT YOUTH WITH COMPLEX CARE NEEDS

Sometimes counties may experience challenges in finding suitable placement and/or services for a youth with complex needs. In the first part of the session, Dr. Loc H. Nguyen will cover various placement settings outside of short-term residential therapeutic programs (STRTPs) for youth with acute needs. The second half of the session will cover various complex care funding opportunities through the enactment of AB 153. The California Department of Social Services will provide a high-level overview of these three different complex care funding categories: 1) child specific requests for exceptional needs 2) county capacity building to address gaps within the continuum of care and 3) the Children's Crisis Continuum Pilot. In this part of the session, Los Angeles County Probation Department and Riverside County Probation Department will share their experiences in these funding efforts.

SUBSTANCE USE TREATMENT AND RECOVERY AND IMPACTS ON FAMILY DYNAMICS

Despite high rates of substance use among youth in the juvenile justice and child welfare systems, assessing needed evidence-based care can be difficult. This session will cover key principles for identifying and addressing substance use and co-occurring mental health needs with dually involved youth. Participants will hear from University of California, San Francisco (UCSF) researchers highlighting telehealth interventions and a discussion about research-informed ways to improve identification of substance use and co-occurring mental health needs and provide tools to aid in linkage to treatment. Additionally, participants will hear directly from a Parent Partner with lived experience about how best to support youth and families with substance use and co-occurring mental health needs either in treatment or exiting an STRTP. Lived experience provides keys to success: Support, Educate and Acceptance that there is not an easy solution. Together, we will make a difference.
