THE 'INVISIBLE INJURIES' OF NEURODEVELOPMENTAL TRAUMA: WHAT IT MEANS AND WHAT WE CAN DO ABOUT IT FOR SYSTEM-INVOLVED YOUTH

Pre-and-postnatal trauma exposure impacts the way in which a new brain organizes and develops. Trauma histories are strongly associated with youth with conduct problems whose 'visible' behaviors may consequently include impulsivity, chronic truancy, use of violence, risk-taking, substance abuse, emotional blunting, and a pattern of engagement that demonstrates a disregard for the rights of others. The persistence of maladaptive brain functions leaves many youth struggling to fit and belong.

UTILIZING ADDITIONAL RESOURCES TO MAXIMIZE THE OPPORTUNITY FOR SUCCESS FOR YOUTH WITH COMPLEX NEEDS

This session will look at the various funding streams to support youth who are in foster care with complex needs. The California Department of Social Services (CDSS) will discuss the availability of Innovative of Model of Care (IMC) rates to support foster children and Non-Minor Dependents (NMDs) with complex needs unable to be met in existing Aid to Families with Dependent Children-Foster Care (AFDC-FC) programs. Also, CDSS will provide a high-level overview of two different state complex care funding resources: 1) county capacity building to address gaps within the continuum of care and 2) child-specific funding. Following CDSS' presentation, there will be a panel that will consist of Monterey, Riverside, and San Bernardino Probation Departments. They will share their experience submitting for and utilizing child-specific funds. This session will also include how to easily complete the child-specific request form. County probation departments are encouraged to come to this breakout session with a possible child-specific funding case scenario they have in mind. There will be Q&A to follow to assist in the child-specific submittal process.

Educational Services: Boys Republic STRTPs have an ongrounds, four-year, WASC-accredited high school through the Chino Valley Unified School District.

Vocational Programs and Work Experience: Vocational training programs include Masonry, Culinary Arts, Teaching Bakery, Landscaping, Farming, Digital Printing, Warehouse Distribution, Welding, Woodworking, and Auto Technology. Students learn the specific skills in a trade and important work habits including reporting to work punctually, following a supervisor's instructions, and caring for equipment and tools.

Mental Health Treatment Services: The case management process is organized around developing positive peer experiences through guided group interaction and is tailored to the needs of the individual resident. Daily group therapy, supervised by social work staff, is the primary treatment modality along with individualized treatment for each youth based on his/her assessment and unique trauma history. A comprehensive range of multidisciplinary clinical services, including psychosocial assessment, individual psychiatric evaluation and treatment, crisis management, individual and family therapy, are integrated within a continuously monitored treatment plan.

Aftercare/Family Reunification Program: Successful discharges are a result of careful assessment, proper treatment, and long-term aftercare planning to meet the youth's needs in a therapeutic manner. Accordingly, the establishment of cooperative alliances with family, referral/placement authorities, and other resources in the social system surrounding the resident is seen as an important programmatic goal.

Substance Abuse Services: The program provides the evidence-based Matrix substance abuse treatment program for all youth assessed to need such services along with weekly group treatment for the purpose of reinforcing the formation of and adherence to a drug free value system.




